

Sanction Chart

The information provided below is to highlight **possible** consequences for typical policy violations of the Code of Conduct and is not absolute; individual circumstances will be reviewed in detail before a decision is rendered.

Aggravating factors will also be considered.

Alcohol Violations

Alcohol policy violation(s) with no aggravating factors	Written warning, community service, reflection paper
Alcohol policy violation(s) with aggravating factors such as: conduct history, amount of alcohol, other minor violation(s)	Probation, Educational Module, Reflection Paper, Deferred loss of Housing, Housing relocation
Alcohol policy violation(s) with significant aggravating factors such as: 2 or more alcohol violations; alcohol violation with violence or assault associated	Removal from Housing, Alcohol Abuse Counseling, College Suspension or Expulsion
Hospital transport for excessive intoxication	Parent/guardian/emergency contact notification, Educational Module, Probation, Removal from housing
Providing alcohol to minors/furnishing a place	Written warning, Reflection Paper, Educational Module
Drinking paraphernalia, including funnels, all manners of drinking games, including but not limited to "water" pong, drinking game paraphernalia, and empty alcohol containers	Written warning, Educational Module, Community Service, Probation

Drug Violations

Possession of drug paraphernalia and/or possession and/or use of cannabis/marijuana with no aggravating factors	Written warning, Reflection paper
Possession of drug paraphernalia and/or possession and/or use of cannabis/marijuana with aggravating factors such as: conduct history, amount of cannabis/marijuana, other minor violations	Community Service, Educational Module, Probation, Deferred loss of Housing
Possession of drug paraphernalia and/or possession and/or use of cannabis/marijuana with significant aggravating factors such as: conduct history, amount of cannabis/marijuana, other minor violations	Educational Module, Marijuana assessment with campus counselor or inspire health group, Removal from Housing, Suspension

Possession and/or use of illicit drugs (such as heroin, cocaine, large amounts of cannabis/marijuana) or of legal medication which is being used outside the parameters of a medical authorization	College suspension of at least one year, AOD assessment and treatment plan, Parent/guardian/emergency contact communication	
Intent to sell and/or sale and/or distribution of controlled substances and/or drugs	Suspension, Expulsion
